Tradepoint Atlantic Employee Referral Program Policy



Purpose

Tradepoint Atlantic (TPA) is a vibrant and multi-faceted business with a team that is uniquely qualified with the critical skills required for success. Our current employees are in the best position to evaluate the suitability of a candidate referral to fit within our cultural and business model. In an effort to encourage employees to help attract and retain qualified candidates for TPA job openings, we offer a bonus-paid Employee Referral Program.

Guidelines for Employee Referral Program

- All TPA employees, except Vice Presidents and Executive Committee Members, are
 eligible for the referral bonus. Temporary, summer, part-time, contract and former
 employees of TPA are not eligible candidates for referral awards.
- The referral date cannot be earlier than the date the job opening is posted. The hiring of a referred employee must occur within 180 days (six months) of the initial referral date.
- The referral must represent the candidate's first contact with TPA.
- The referring employee must agree to have his or her name used when the company contacts the candidate.
- The first employee to refer a specific candidate will be the only referring employee eligible to receive credit for that candidate.
- Only candidates who meet the qualifications for the position will be considered.
- All candidates will be evaluated for employment consistent with company policies and procedures. Hiring and retention of any candidate is at the discretion of the executive committee.
- All information regarding the hiring decision will remain strictly confidential.
- Any disputes or interpretations of this employee referral program will be handled through Human Resources.
- To be eligible for an award, employees must refer candidates to Human Resources through the employee referral program link on TPA's Intranet or by using the attached candidate referral form.
- All referral bonus payments will be paid within two weeks after the full-time, permanent, hired individual completes 120 days of employment and satisfying job performance with Tradepoint Atlantic.
