The starting pay rate for this position is \$21.44 per hour, increasing to \$24.05 per hour after successful completion of a 90-day training period. Warehouse employees may choose to participate in the Operating Engineers Local 37 Pension and Annuity Funds. They will also be included in the Union's medical plan, with employer contributions covering 100% of single coverage and 70% of dual/family coverage. Employees will accrue vacation time and sick and safe leave. Additionally, they are eligible to participate in the Company's 401(k) retirement plan, which includes a company match of up to \$750 per year (subject to eligibility requirements). This position reports to the Warehouse Manager.
